Ambulance – Supervisor Chapman reported as of this July 2022 report there are 12 EMTs and 11 are active. There are 8 EMRs and 7 are active. There were no runs in Field for July. Fire – Supervisor Chapman gave the July 2022 fire report. July's training was water rescue. July 25 was the business meeting and some ladder truck training.

Roads and Bridges - Supervisor Knutson reported the clerk had gotten the snow plow application in. The roads are good. He reached out for three estimates for tree clearing on Neva Road and only

Dutchman Tree Service responded. They began the work and their machine broke down so they worked by hand and with the chipper. The north end needs to be finished. He has received no more information on the storm damage money yet.

Hospital -Hospital Representative Mike Enzmann reported a memorandum of understanding was signed with the union to provide incentives for staff. A garage redesign bid was accepted. The capital budget and levy request were both approved with no change in levy. Revenue is up due to outpatient. Security cameras in the parking lots are working.

Cemetery - Supervisor Knutson reported the church service there was good and Trinity Lutheran left 35 chairs there .The entry way needs painted. Treasurer Brunner will check on plaque prices for the benches (Pearson, Picek and ?) plus a plaque inside for others who donated for the church improvements.

Joint Powers Board - Chairman Fulcher talked to the school principal and reported Thistledew will clear the school forest trail and a new teacher is interested in the project.

Planning and Zoning – No report.

Hall- Supervisor Knutson reported we can't get a larger LP tank from Ferrell Gas. The tank area needs to be blocked off for the snow plow and a path shoveled to it for deliveries. A motion was made by Supervisor Chapman, seconded by Supervisor Knutson to order a chair cart \$397.84 for the chairs at the hall. Motion carried unanimously. The clerk will order it.
