Hospital – Hospital Representative Mike Enzmann reported the Care Center was awarded a Minnesota Nursing Performance based incentive payment program grant. Staffing is still an issue. Outpatient Services have resumed including monocional antibodies infusions. Currently 1 ER room and 1 isolation room are negative pressure. A grant was applied for to convert all 7 hospital rooms to negative pressure. September was strong financially.

Cemetery – Supervisor Knutson reported the new windows are stored at the church. The old floated glass will be saved when the new ones are installed. Trinity Lutheran Church will install battery operated candles in the windows for the holiday season. Roots were taken off the Jowalski grave. Joint Powers Board – School Forest Liaison Keith Aho reported no updates available.

Hall- There was discussion about purchasing a big screen tv at the hall and also internet and providing a clerk and treasurer's office.
