Chairman Enzmann made a motion to recommend the following levy of \$62,000 for 2023 payable in

the year 2024 at the Annual Meeting:

General \$16,000

Road \$7,000 Fire \$19,000 Ambulance \$6,000 Cemetery \$6,000 Hall \$8,000 Seconded by Supervisor Knutson. Motion carried unanimously. Committee Reports: Ambulance - No report Fire- Supervisor Chapman and Deputy Clerk Chapman reported on the two fire meetings they had with Harold Johnston, Gary Albertson, and fire department representatives. The 2023 budget numbers were discussed. The department is requesting a per capita increase from \$20 to \$40. They also hope to have fundraising efforts. Supervisor Chapman made a motion to approve the township pay the increase to \$40 and also to increase the amount to \$45 if the other townships agree to that amount. Seconded by Supervisor Knutson. Motion carried unanimously. Another fire meeting with all the townships will be held February 27, 2023. Road and Bridges – Supervisor Knutson reported more gravel will be needed for South Riddell. Cemetery - Supervisor Knutson reported the outside of the church windows will be done in the spring. There was discussion about more fill needed to enlarge the cemetery and will be a topic for the May cemetery inspection. Hall - Supervisor Knutson reported LP was ordered again for the hall. The hall entrance was shoveled and everything was fine inside. He made a motion seconded by Supervisor Chapman to increase the insurance coverage on the hall and cemetery church from \$100,000 to \$250,000. The payment would increase by \$1522. Hospital – Hospital Representative Mike Enzmann reported the pharmacy audit was conducted and was accurate. Staffing is still a problem. The garage is roughed in and will be completed when the snow is gone. The health fair will be in September. Theresa Martinson will be the hospital rep. from Angora. The federal health emergency will be over May 11. Joint Powers Board - Supervisor Knutson reported he introduced himself to the Northwood's school principal as a contact for the school forest. Chairman Enzmann reported he is officially a representative for Field Township on the Joint Airport

Zoning Board. Existing zoned areas at the Cook Airport and proposed zoning does impact land within

Field Township boundaries on the east side.

Planning and Zoning – Correspondence was received from the St. Louis Planning Dept. concerning

amendments to Ordinance 61 for subsurface sewage treatment systems. The board had no objections.

Broadband- Elizabeth Chapman has not heard from the IRR about a broadband meeting. Old Business- None

New Business-Clerk Chapman presented a resolution to accept the election judges as presented by the

clerk (Dawn Simpson, Tim Chapman, Joel Knutson) and others who are trained if needed to serve at

the annual election and also as an absentee ballot board if needed. Resolution carried unanimously.

Deputy Clerk Chapman reported on the St. Louis County Assoc. of Townships meeting he attended

virtually on January 25, 2023. A Better in Our Back Yard presentation promoted development of natural

resources in the area. St. Louis County Public Works Commissioner Nelson addressed concerns about

expediency of plowed roads. Monetary and workforce limitations have created challenges for the department.
