Road and Bridges – There will be a road review in May.

Hospital – Hospital Rep. Mike Enzmann reported the Care Center has 4 empty beds due to staffing

shortage. The contract with Northland Anesthesia Associates is being discontinued. The flooring project

is nearly complete. There were record breaking patient volumes from August to year end. Cemetery-

Supervisor Knutson will work on information to get bids to install windows. Joint Powers Board –

Planning and Zoning – A letter was shared with information about an amendment to Ordinance 60.

Hall- There was discussion about the remodeling - the building might need to be lifted and insulation

added to the floor. Chairman Fulcher and Jay Brunner will get information about an engineer to inspect

the building. There was also discussion about internet access at the hall and possibly an internal alarm to

alert if heat is off. It was suggested every fall make sure the LP gas tank is filled..When the bill from the

plumber is received the clerk will check if insurance will cover the expenses incurred when the heat was

off.

New Business – Treasurer Brunner gave the oath of office to re-elected Clerk Pat Chapman and re-elected Supervisor Tom Chapman.

Chairman Fulcher made a motion to donate \$600 to the St. Louis County Fair Association Seconded by

to the Cook Public Library. Seconded by Supervisor Knutson. Motion carried unanimously. Chairman

Fulcher made a motion to donate \$1500 for the maintenance of the Cook Community Center. Seconded

by Supervisor Knutson.Motion carried unanimously.

Daily rental for residents of the township for the Field Town Hall will be \$20.00 per day with a \$20.00

refundable damage deposit. A 20.00 utility rate will be charged October 1 – May 1. No charge if the

group is a local community oriented organization. Board approval will be required for additional uses.

The clerk or supervisor will give hall user instructions, checking the hall before and after. The "Little

Fork Church" cemetery building is also available for rental during summer months for \$20 per day plus

\$20 refundable deposit.

A motion was made by Supervisor Chapman to accept the language. Seconded by Chairman Fulcher.

Motion carried unanimously.

A motion was made by Chairman Fulcher for the following payroll amounts:

Meetings – full day (more than 4 hours) \$120

Meetings- half day (4 hours or less) \$60

These fees apply to committee work and meetings for the township.

Board meeting- \$75

Mileage- \$10

The general hourly wage and election judge wage is \$18 or as mandated by law with the hourly executive rate \$20 per hour. The cemetery caretaker hourly wage is \$17.

Treasurer's Salary - \$250 monthly. (\$3000 yearly)

Clerk's Salary - \$450 monthly (\$5400 yearly)

Seconded by Supervisor Chapman. Motion passed unanimously.

Supervisor Chairman made a motion to continue to provide \$750 allowance for insurance coverage for

each township board member, hospital representative, clerk, and treasurer to be used as deemed appropriate by the recipient. Seconded by Chairman Fulcher. Motion carried unanimously. The township will abide with the currently published federal rate for mileage. (\$.58.5) The resolution to

reestablish precincts and polling places was adopted which reestablishes the boundaries of the voting

precincts and polling places as Precinct 1, Field Town Hall, 1627 Highway 25, Cook, Mn 55723. The

entire township is included in Precinct 1.

The next regular board meeting will be April 12, 2022, 7 pm at the Field Town Hall. The Board of

Appeal will be at the town hall May 3, 2022 from 11 am - 12 noon. Motion to adjourn made by Supervisor Chapman, seconded by Supervisor Knutson. Motion carried unanimously. Adjournment
