The "Little Fork Church" cemetery building is also available for rental during summer months for 20 per day plus 20 refundable deposit.

A motion was made by Chairman Enzmann for the following payroll amounts:

Treasurer's Salary - \$250 monthly. (\$3000 yearly)

Clerk's Salary - \$450 monthly (\$5400 yearly) Deputy Clerk paid hourly.

Seconded by Supervisor Chapman. Motion passed unanimously.

Conflict of interest information will be reviewed.

Supervisor Knutson made a motion to purchase a cell phone for township use only.Seconded by Supervisor Chapman. Motion carried unanimously. Chairman Enzmann will research the purchase. Supervisor Chairman made a motion to continue to provide \$750 allowance for insurance coverage for each township board member, clerk, deputy clerk and treasurer to be used as deemed appropriate by the recipient. Seconded by Supervisor Knutson.. Motion carried unanimously. The township will abide with the currently published federal rate for mileage. (\$.65.5) The resolution to reestablish precincts and polling places was reviewed which reestablishes the boundaries of the voting precincts and polling places as Precinct 1, Field Town Hall, 1627 Highway 25, Cook, Mn 55723. The entire township is included in Precinct 1.

The next regular board meeting will be April 11, 2023, 7 pm at the Field Town Hall. The Board of Appeal will be at the town hall May 2, 2023 from 11 am - 12 noon. Motion to adjourn made by Supervisor Chapman, seconded by Supervisor Knutson. Motion carried unanimously. Adjournment time 9:15 p.m.
